



## **X Lotto “Buy One, Get One Free” Promotion TERMS AND CONDITIONS**

1. **Acceptance of Terms and Conditions:** Instructions and information on how to enter the Promotion form part of these Terms and Conditions, and entry into the Promotion is deemed acceptance of these Terms and Conditions.
2. **Type of Promotion:** This **Promotion** is a promotional lottery conducted pursuant to the *State Lotteries Act 1966* (SA), the Lotteries (General) Rules, and the Lotteries (Promotional Lottery) Rules.
3. **Promoter:** The Promoter is Tatts Lotteries SA Pty Ltd (ABN 41 146 245 007) of 188 Richmond Road, Marleston SA 5033, telephone 131 868 (“**Promoter**”). The Promoter and its related companies are referred to as the **Promoter Group**.
4. **Participating Outlets:** This Promotion is available from all South Australian Lotteries All Product Outlets, the **Lott** website or App (“**Participating Outlets**”). Entries purchased through resellers are excluded from this Promotion.
5. **Promotion Period:** Entry into the Promotion is open from 00:01:00 Australian Central Daylight Time (ACDT) on 6 December 2018 until 23:59:59 ACDT (midnight) on 8 December 2018 (“**Promotion Period**”).
6. **Eligibility:** Entry is open to residents of South Australia who are 18 years of age or older (“**Eligible Entrants**”).
7. **How to enter:**
  - 7.1 Eligible Entrants must purchase a Saturday X Lotto 50-game Maxi QuickPick entry (excluding syndicate entries) valued at \$34.90 on a single ticket for the \$30 million Megadraw drawn on Saturday 29 December 2018 (Draw 3907) from any Participating Outlet during the Promotion Period.  
  
 (“**Qualifying Entry**”)
  - 7.2 Each player who has a Qualifying Entry will be issued with one (1) complimentary Saturday X Lotto 14-game Regular QuickPick entry (valued at \$9.80) that is valid for the Saturday X Lotto \$30 million Megadraw to be drawn on Saturday 29 December 2017 (Draw 3907). A maximum of 22,000 bonus Regular QuickPick tickets will be issued  
  
 (“**Complimentary Ticket**”)
8. **Restrictions:**
  - 8.1 There is no limit on the number of Qualifying Entries that an Eligible Entrant may purchase during the Promotion Period, subject to the Lotteries (Saturday X Lotto) Rules.
  - 8.2 The Complimentary Ticket will not be redeemable for cash or other goods (save for cash prizes won on the complimentary ticket), and is not transferable.
  - 8.3 Where any prizes are won on the Complimentary Ticket, the Promoter reserves the right not to pay any prize won where the corresponding Qualifying Entry has been cancelled. All tickets are subject to security and verification checks at the absolute discretion of the Promoter.
  - 8.4 The Promotion will terminate prior to the designated end time in the event that the Promoter has issued the full predetermined number of 22,000 Complimentary Tickets.
9. **Saturday X Lotto:** This Promotion does not affect the normal operation of Saturday X Lotto draws or other promotions conducted by the Promoter during the Promotion Period.
10. **Prizes:** The total retail value of all Complimentary Tickets for the ‘Buy One Get One Free’ Promotion is capped at \$215,600.
11. **Cancellation of entry:** If a Qualifying Entry by which an Eligible Entrant receives a Complimentary Ticket is cancelled after purchase, the Complimentary Ticket is also cancelled and such cancellations will be subject to the ticket cancellation provisions of the Lotteries (General) Rules.

12. **No right to transfer prize:** The right to a prize in this Promotion is not transferable, assignable to another person or redeemable for cash.
13. **Validity of entry:** The Promoter reserves the right, at any time, to verify the validity of a Qualifying Entry or Complimentary Ticket or disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. The decision to verify, validate or disqualify a Qualifying Entry or Complimentary Ticket is at the Promoter's absolute discretion.
14. **Computer System Issues:** No responsibility is accepted for late, lost or misdirected entries. The Promoter is not responsible for any problems or technical malfunction of any computer system, software or internet difficulties, including any damage to an entrant's computer, resulting from participation in the Promotion. Any costs associated with accessing or submitting entries are the entrant's responsibility.
15. **Liability:** The Promoter will not be liable for any loss or damage or personal injury suffered or sustained in relation to the Promotion or a prize except for any liability which cannot be excluded by law.
16. **Force Majeure:** If the Promoter is prevented from or delayed in performing an obligation by Force Majeure then the obligation is suspended during, but for no longer than, the period the Force Majeure continues and any further period that is reasonable in the circumstances. "**Force Majeure**" means an event beyond the reasonable control of the Promoter, which occurs without the fault or negligence of the Promoter.
17. **Delay or modification to conduct of the Promotion:** Subject to obtaining the approval from the regulator (if applicable), the Promoter reserves the right to delay or modify any aspect of this Promotion if for any reason it is not capable of running as planned (including without limitation, by reason of infection by computer virus, bugs, tampering, fraud, technical failures, power failures or due to any other causes unforeseen or beyond the reasonable control of the Promoter which corrupt or affect the administration, security, fairness, integrity (including extracting the draw file) or proper conduct of the Promotion) but only to the extent necessary to overcome the issue that is affecting the running of the Promotion as planned.
18. **Changes to the Terms and Conditions:** If the Promoter reasonably considers that a change to these Terms and Conditions is likely to (a) benefit entrants, or (b) be of no material detriment to entrants, then subject to obtaining approval from the regulator (if applicable), the Promoter can make the change and will place a notification on the Promoter's website ([thelott.com/salotteries](http://thelott.com/salotteries)).
19. **Privacy:**
  - 19.1 The Promoter Group is authorised to collect certain personal information for the purpose of entry into the Promotion under the legislation set out in clause 2 above.
  - 19.2 By participating in the Promotion, an entrant authorises the Promoter Group, and contractors and agents of the Promoter Group, to access, collect and use the personal information collected about the entrant, and disclose personal information about the entrant, to the Promoter Group and its contractors and agents (which may include disclosure to financial institutions, lawyers, auditors, IT service providers, mail service providers, marketing service providers, market research companies, selling agents) and gaming and other regulators, for the purposes of –
    - (a) conducting the Promotion;
    - (b) providing the entrant with information about products and services of the Promoter Group. Such information may be provided electronically, or by contacting the entrant by telephone or other means, until such time as the entrant asks the Promoter not to provide further information;
    - (c) publishing the name of a prize winner via electronic communications and on the Promoter's website(s), Facebook page(s), Instagram account(s) and Twitter account(s) on the day following the selection of a prize winner; and
    - (d) disclosing the initial(s), surname and suburb or town of a prize winner to selected media outlets as well as the Promoter's website. A prize winner may be asked by the Promoter to participate in publicity associated with the Promotion. A prize winner will have the right to elect whether or not to participate in that publicity.
20. **Failure to provide personal information:** If an entrant does not provide the personal information requested, or if an entrant provides inaccurate information, the entrant cannot participate in the Promotion and will not receive information about products and services of the Promoter Group.
