



## Ex Gratia Statutory Declaration

### Conditions of Claim for prizes over 12 months.

1. The Rules under the State Lotteries Act 1966 (as amended) require that winners produce the winning ticket when claiming a prize. The bearer of the ticket will be paid if Tatts Lotteries SA is satisfied he/she is the ticket's rightful owner.
2. If a prize in a lottery has not been collected or taken delivery of within 12 months of the relevant day, the prize is forfeited to the South Australian Lottery Commission and transferred to the Unclaimed Prize Reserve.
3. **A Non-refundable Administration fee of \$22 is required to accompany this claim per ticket.** Tatts Lotteries SA will accept payment via cheque, money order, credit card (below) or in person by EFTPOS or cash.
4. Payment of prizes will be made as per the Prize Claim form, or original cheque issued.
5. The claimant will indemnify Tatts Lotteries SA against any subsequent claims or payments on the ticket to which the claim applies. Any prizes already paid will not be considered.
